SmartPool will, at its sole option, either repair the product at a nominal charge or replace the product. All repaired or replaced products will be returned at the homeowner's expense.

SIX MONTH PRODUCT WARRANTY

Six month limited warranty from date of purchase for manufacturing defects under normal use and service and installed according to the instruction manual. This warranty is subject to the terms, limitations and exclusions described below and no other warranties, express or implied are understood.

What is covered: The product itself, including electronics, electrical components and housings are warranted to be free from defects in material and workmanship when leaving the factory.

What is not covered: Product damaged by improper installation or maintenance. Batteries (if applicable). The product is not warranted against damage due to improper draining, winterizing, storage or acts of God. Consequential damages and labor are excluded from this warranty. Claims will not be accepted for products damaged in transit unless damage to shipping container is noted at time of delivery on transport companies' delivery bill. No performance or satisfaction guarantee is claimed by SmartPool on this product. It is the responsibility of product owner to regularly test and check product for function and safety.

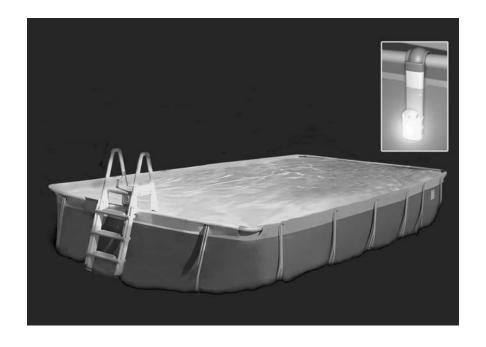

"Ultra" Underwater Lighting System for Framed Soft-Sided Pools

Installation/Operation manual/Warranty



1. Hang the light fixture onto the rail of your pool, as shown. Keep the light fixture vertical. Make sure the top of the clear lens is at least 3 inches below the water level.





2. Hold the smaller metal piece against the underside of the rail and push up; then tighten up the 2 screws that hold the 2 pieces together.



Adjust the 2 hex socket head set screws until the metal clamp grips the rail tightly.

Slide the smaller plastic up and attach it to the lower part of the metal clamp by the 4 smaller screws. Tuck the wire in the trough of the metal clamp.



4. Cover the metal clamp with the plastic cap. Push it down until it fits snugly with the light fixture.

You may bury the wire in a shallow slot in the ground to hide it but would allow for easy removal.

The transformer should be mounted to a convenient surface. Mount the transformer off the ground approximately 18 inches using the keyhole slot in the casing.

Plug only into a 110V outlet protected by a ground fault circuit interrupter.





NOTE:

For smaller diameter rails, place the small rail adapter (provided) onto the rail prior to hanging the metal clamp (see accompanying picture).



Operation:

Operate only when the light is submerged in water.

After plugging in, push the rubber button to activate. Rotate the knob on the transformer to use high or low setting. The light automatically turns off in approximately 3 hours for convenience and longevity.
